The Certificate in Nonprofit Management offers specific knowledge and skills related to leadership, financial management, governance, and strategic planning. In addition, you can design your certificate to focus on a range of topics, including:

- Strategic management
- Financial management and resource development
- Policy analysis in a particular policy area
- International non-governmental organizations
- Organizational innovation and entrepreneurship

## THE BENEFITS

The curriculum is designed for individuals who have at least two years of work experience in the nonprofit field but do not have formal training in the management aspects of leading a nonprofit organization. The certificate is:

- Designed for working professionals
- Shorter than a degree program
- Transferable to Humphrey School degree programs
- Flexible and offered at various times
- Taught by University of Minnesota faculty members

# **CERTIFICATES WITHIN DEGREE PROGRAMS**

Credits taken in the Certificate in Nonprofit Management may transfer to Humphrey School master's degree programs, if all the admission requirements for the degree program are met. Coursework taken for the Certificate in Nonprofit Management may be applied towards a Humphrey School graduate degree or programs outside the Humphrey School. ### REQUIREMENTS

Core requirements are 7.5 credits, taken with three core courses:

- Introduction to Financial Analysis and Management
- Strategic Planning and Management
- Management and Governance of Nonprofit Organizations

# **ELECTIVES**

You may select courses from a large variety of electives to bring your total to 13 credits. A faculty adviser must approve your program plan. Other courses may be used if approved by your adviser.

## PREREQUISITES

- A bachelor's degree from an accredited institution
- A preferred performance level for your undergraduate grade point average (GPA) of 3.0
- Documentation of two years of paid or unpaid experience in a nonprofit organization in one or more of the following areas: management of a budget, supervision of staff, direct service work with clients, development of programs (implementation and evaluation), fundraising, grant writing, regular participation in board meetings and/or on board committees
- No Graduate Record Exam (GRE) is required

- TOEFL/IELTS scores (required for most non-native English speakers)
